It is agreed by and between the parties hereto that the sole modification of, changes in, and amendments to the Agreement pursuant to this Amendment are as follows:

TERMS

1. Recitals

THE ABOVE RECITALS ARE EXPRESSLY INCORPORATED IN AND MADE A PART OF THE AMENDMENT AGREEMENT AS THOUGH FULLY SET FORTH HEREIN.

- Schedule A Scope of Services is amended to include additional services required for Engine Company 109 to perform Surveyor Services. The scope for this service is detailed in Attachment A to this Amendment 2.
- 3. Schedule C Compensation of the Consultant is revised as follows:
 - C.1 The Consultant shall be paid the not to exceed amount of \$7,400.00 for the additional services outlined in Attachment B of this Amendment 2.

The Not to Exceed Fee is increased to a total of \$14,200.00.

Execution of this Amendment by the Consultant is duly authorized by the Consultant, and the signature(s) of each person signing on behalf of the Consultant have been made with the complete and full authority to commit the Consultant to all terms and conditions of this Amendment.

All capitalized terms not defined herein shall have the meaning ascribed to them in the agreement. Except as and to the extent that the terms of the Agreement are amended and modified herein, all terms of the Agreement shall remain in force and effect.

The terms of the Agreement remain in full force and effect except as modified in this Amendment.

The Scope of Services includes but is not limited to the following tasks:

- Subdivide two parcels between 23rd and 24th and Kedzie for zoning purposes;
- Additional topography: New topography will include fifty (50) feet South and fifty (50) feet West of the intersection of 24th and Kedzie. Included in the topography will be grade shots every twenty-five (25) feet, all visible improvements, manholes with rim elevations and inverts, light posts, signs, sidewalks, etc. A verification of the fifty (50) foot North and East of 24th. Kedzie will also be included, bench mark datum will be established from the City of Chicago Datum; and
