AMENDMENT TWO DESIGN-BUILD SERVICES AGREEMENT DEMOLITION OF MALCOLM X COLLEGE CONTRACT NUMBER PS2058

This Amendment to Agreement Number PS2058 is effective <u>July 12, 2016</u>, by and between the **Public Building Commission of Chicago**, a municipal corporation organized and operating under the Constitution of the State of Illinois and having its principal office at Room 200, Richard J. Daley Center, 50 West Washington Street, Chicago, Illinois 60602 ("Commission"), and **Old Veteran Construction**, **Inc.** (OVC), an Illinois corporation, with offices at 10942 S. Halsted St., Chicago, Illinois 60628 (Design-Builder) and hereby amends the Agreement for Design-Build Services for the Demolition of Malcolm X College (the "Agreement") dated November 10, 2015 and any subsequent amendments, between the Commission and the Design-Builder as further set forth herein.

RECITALS

WHEREAS, the Commission, on behalf of the City of Chicago, has undertaken the design and demolition of Malcolm X College, located at 1900 W. Van Buren St., Chicago, Illinois, 60612 (the Project); and

WHEREAS, the Commission requires certain design/build services (the "Services") described in this Agreement for the Project; and

WHEREAS, at its regular meeting, on November 10, 2015, the Board of Commissioners of the Public Building Commission of Chicago (PBC Board) approved the appointment of Old Veteran Construction, Inc. to be the Design-Builder for the Project; and

WHEREAS, at its regular meeting on <u>July 12, 2016</u>, the PBC Board approved a project undertaking that will allow a Guaranteed Maximum Price of **\$12,875,000.00** with OVC for the Project; and

WHEREAS, the Commission and Design-Builder desire to amend the Agreement and establish the Project GMP as provided for in Article 3.2 of the Agreement; and

WHEREAS, the Commission and the Design-Builder desire to amend the Agreement to establish a Project GMP for the Project to facilitate environmentally safe demolition of Malcolm X College; and

WHEREAS, the Board of Commissioners of the Commission approved the Project GMP by approving the Project undertaking at its regular meeting <u>July 12, 2016</u>; and

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the Commission and Design-Builder (collectively, the "Parties"), the Parties hereby agree to amend the Agreement and establish the Project GMP as follows:

AMENDMENT

ARTICLE 1 - INCORPORATION OF RECITALS

The recitals set forth above are hereby incorporated in and made a part of the Agreement.
