In the absence of the Chairman Rahm Emanuel, the meeting was called to order by Commissioner Sax as and the presence of a quorum was established.

Following the roll call, a public participation period was conducted pursuant to Section 2.06(g) of the Open Meetings Act. George Blakemore and Steven A. Garth, Sr. had previously

registered to provide comments under the guidelines established by Resolution No. 7611 approved by the Board of Commissioners on January 11, 2011. George Blakemore provided comments regarding the negative effects of illegal immigrants on the availability of jobs for African Americans and the need to provide jobs and contracts for African Americans on public construction projects. Commissioners Clark, Ruiz and Sax responded that they did not agree with the comments provided by Blakemore. Steven A. Garth, Sr. provided background information regarding his company, which recently completed was its largest contract for Public Building Commission (the Jones High School Project). He also commended the Public Building Commission for its use of African American-owned companies in constructing various projects.

Next, Acting Chairman Sax presented to the Board of Commissioners for consideration of approval the minutes of the meeting held on August 8, 2017. The reading of said minutes, which had previously been distributed, was dispensed with and upon motion duly made and seconded, the minutes of the August 8, 2017 meeting were unanimously approved.

The next item on the agenda was consideration of approval of a Resolution commending the service of Thomas J. Kotel as a Commissioner of the Public Building Commission of Chicago. Commissioner Sax commended Commissioner Kotel for his extensive knowledge of the construction industry and invaluable contributions to the Public Building Commission. The following resolution was read into the record by the Executive Director:

#### **RESOLUTION NO. 8400**

WHEREAS, on November 13, 2012, Thomas J. Kotel was appointed as a Commissioner of the Public Building Commission of Chicago with the advice and consent of City Council and has distinguished himself as a member of the Board during his tenure; and

WHEREAS, Mr. Kotel has served on the Boards of Trustees of multiple benefit plans covering Local 597 Pipefitters, overseeing invested assets in excess of \$2 billion. In addition to his work as a trustee on those plans, he serves as an Officer or Delegate to numerous labor organizations. Mr. Kotel is a Delegate and Committee member of the Illinois State Pipe Trades Association Finance Committee and serves as Local 597's Delegate to the Chicago and Cook County Building Trades Council. He also serves as a Delegate and C.O.P.E. Representative for the Chicago Federation of Labor and has served as a Delegate numerous times at the United Association Convention. He has also served on the Healthcare Labor Management Committee for the Metropolitan Water Reclamation District of Greater Chicago; and

**WHEREAS**, Mr. Kotel has made invaluable contributions to the Public Building Commission to facilitate its mission of providing sustainable facilities to improve the quality of life for the residents of the City of Chicago. Through his knowledge and experience in the construction industry, he has provided leadership to the Commission in regards to labor, workforce programs, and union issues:

**NOW, THEREFORE, BE IT RESOLVED** that Thomas J. Kotel is hereby commended by the Chairman, members of the Board of Commissioners and the Executive Director of the Commission for his leadership and dedicated service to the Public Building Commission and the citizens of the City of Chicago and Cook County.

The Executive Director provided a report on four bid openings for school projects and also provided an update regarding the roll out of the expanded use of the Richard J. Daley Center Plaza to include private and commercial events.

The Director of Procurement reported on the following specialty consultant task order awards:

- A task order award issued to Carlson Environmental, Inc. in the sum of \$92,123.72 for environmental engineering services for the Esmond Elementary School Annex.
- Task order awards to Tetra Tech, Inc. in the sum of \$77,332.00 for environmental engineering services and to Carnow, Conibear & Associates, a WBE firm, in the sum of \$81,198.00 for environmental renovation and demolition services at the Ebinger Elementary School Annex.

Task orders awards for environmental renovation/demolition services as follows;

- GSG Consultants, Inc., a MBE firm, in the sum of \$11,911.20 for the Jamieson Elementary School Annex and \$83,720.00 for the Mt. Greenwood Elementary School Annex.

- Chicago Vocational Career Academy Exterior Lighting and Decommissioning Project for a total credit of (\$148,378.68) for unused Commission's environmental allowance and contingency.
- Walter Payton College Prep for a credit of (\$283,083.00) for unused Commission's contingency.
- Southeast Area Elementary School for a total credit of (\$454,117.00) for unused site work and camera equipment allowance.

The Chief Development Officer also reported that five field orders were approved and issued on two projects.

The AO Committee accepted the recommendations and reports from the PBC representatives.

The Board also approved by Board Report No. 17-0828-RS8 an increase in the funding authority for Sheridan from \$5,000,000 to \$8,700,000.00.
